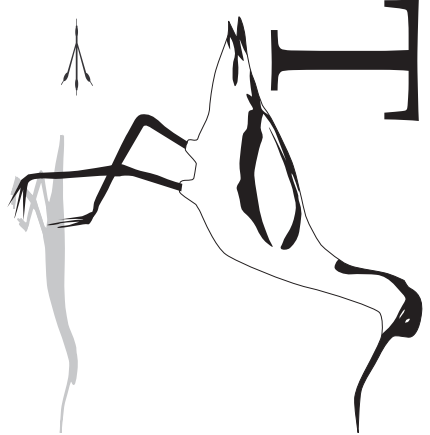

Access Management Group... New Management Starting December 20

We have experienced on-going problems with our transition from Heritage to Association Management Advisory Group (AMAG). Because of our inability to resolve these problems successfully, we have terminated the contract with AMAG and hired Access Management Group. Access Management Group (AMG) was one of four companies we interviewed. Our criteria were to have a company located nearby, able to handle monthly payments, handle a majority of single family communities versus condos/townhomes, and responsive to homeowner and BOD requests. We had two finalists after our interviews.

The tie breaker was when we interviewed John Thisdale, the property manager that would be assigned to us by AMG. John is a retired Delta employee with a lot of experience in customer service. We were all very impressed with him. When we followed up with communities he managed, he received glowing recommendations.

We will not only save money from reduced management fees, but will have the benefits of on-line access to information. This information includes management and financial reports for the BOD. Homeowners will also have on-line access to their account information. Plus, the auto-debit feature for dues payments will be available.

Please send December payments to AMAG as usual. You will be receiving a new coupon book prior to the end of the year that will have the mailing address for your payments. There will also be instructions for obtaining a login to AMG and setting up an auto-debit payment. If you are using on-line bill pay with your bank, please be certain to change the address there. If you prefer to pay annually or quarterly, just bundle the appropriate number of coupons and return them with your check.

Security Issues for Avocet

On Monday, November 10, there was a robbery on Natchez Trace Court in Aprenmont Subdivision. The first reports indicated that the husband was injured and that the Gwinnett Police took 25 minutes to respond. After checking with Cpl. Wilkerson, our Police Liaison Officer for the COPS Program, we learned that the lady of the house arrived home around 10:30 p.m. and that an unknown number of suspects grabbed her purse after she left her car. These suspects left on foot, and no one was injured. It is believed that the suspects may have been hiding in the bushes on the homeowner's property. The lady was not sure that the suspects were armed. A total of four police cars responded, with the first arriving in 12 minutes. The police were not given a very good description and were unable to find the suspects. As is often the case, the first reports of this crime were different from what actually happened.

The Community Affairs Policeman for this precinct is Cpl. Marches. He said that this crime is another incident in an on-going series of robberies. The victims in these cases are primarily Asian and restaurant owners. They are being targeted for these reasons.

Historically there are not many incidents in our neighborhoods. We should be alert to suspicious activities. We should contact the police if we see suspicious people or vehicles.

A few years ago, there was an attempted robbery in Avocet that was

very similar to this crime. Fortunately, nothing was taken in that attempted robbery. Some good advice for our neighborhood:

- Do not bring home money from a business if possible.
- Please be observant and call 911, if someone is following you or waiting near your house. Wait for the police to arrive before leaving a vehicle.
- Please add timers to outside lighting if you come home frequently after dark. Please prune shrubs around your home to remove hiding places.

Cpl. Wilkerson has offered to meet with us to discuss recent criminal activity. He suspects that the people breaking into area vehicles at night may live in apartments near our neighborhood. Cpl. Wilkerson has requested a more specialized patrol for our community, and he hopes that the suspects will be apprehended soon. Please park vehicles in locked garages as much as possible. If vehicles must be parked in the driveway or street, please remove all valuables. Please keep vehicles locked.

On November 13, there was a burglary in Spalding Corners. Avocet faces the risk of burglaries as the holiday season approaches. If you have a burglar alarm, please arm it whenever you leave. Make sure all of your doors and windows are locked and outside lights are on. Set interior lights, televisions, and radios on timers to make your house appear occupied if you are traveling. Have someone pick up your mail and newspapers.

On November 20, a Peachtree Station woman believed that she was stalked inside the Target where Peachtree Corners and Peachtree Parkway split. She had the assistant

manager walk her to her car. Another woman had a similar incident happen to her there. The Gwinnett Police have reported frequent robberies occurring outside the Publix and Target at this location. A security patrol is occasionally present in the parking lot during the evenings. Regardless of where you shop, please be alert to your surroundings. Follow the example of this woman, if you feel someone is stalking you.

Hail Damage

Apparently, Avocet experienced more roof damage from the March hail storm than many of us realized. It would be prudent, if you have not yet had your roof checked, to so. Insurance will pay to have your roof replaced if you have damage.

Roof replacement does require ACC approval. You can get the ACC request form at <http://avocet-hoa.org/Documents/ACC%20Change%20Request.pdf>. Please include a description of the type of shingle you will be using as well as the color. You can include either a brochure with this information or a link to a web site where the material can be viewed. The new "architectural" shingles are permitted.

As a reminder, only "For Sale" signs are permitted in our neighborhood. If your contractor would like to advertise, the best place to reach your neighbors is by posting a recommendation as described above.

Many folks walk through the amenities area for exercise or to walk your dogs. When you do, we would like to ask for your help to secure the area. If you are in the area and there is no one at the courts or the pool, please check the following:

- Ensure the gates at the courts and the pool are shut and latched. There have been a number of occasions where gates were left open.
- Ensure the door to the clubhouse is closed and the window in the bathroom hallway is closed and secure.
- If the umbrellas by the pool are open, please close them. If they are open, they can be damaged by the wind.

Satellite Dishes

Satellite dishes cannot be placed on the front of your home. Corner lots have 2 "fronts". Satellite companies can place the dish so it is not clearly visible from the street. This is not something they like to do. In fact the

installers will attempt to convince you that any other placement is impossible. However, if instructed by you that our covenants require the dish placement to be obscured from the street, they will find a way to make it work.

Advanced Voting Information: Georgia voters no longer need a reason for voting prior to election day. Any registered voter who is eligible to vote may cast a ballot prior to election day in one of the following ways.

Absentee ballots: Voters who want to vote early using a paper ballot may request an absentee ballot by mail or fax. Marked ballots must be returned to the Elections Office by mail or by the voter in person in time to be counted on Election Day, December 2nd. All votes will be tallied after the polls close at 7:00pm.

Early voting in person is available the week of November 17 – 26, 2008 (closed on November 27 and 28 for Thanksgiving), at the following location:

Absolutely no type of voting is available on the Monday before Election Day on Tuesday. Satellite Advanced Voting locations will not be open for the runoff election.
